Divided into groups: 234 cases of economic, 18,777 cases of mental, 13,658 cases of physical violence and 7,174 cases of harassment were identified. Worst of all, 34,330 cases, or 87 percent, of domestic violence occurred. This means that about 40,000 women a year are forced to obtain protection orders under violence and harassment, and 87% of them have sought refuge from their loved ones.

In fact, several times a month or once or twice a month, stories of women who have not given birth to a son, eaten too much, or been oppressed for other reasons are spread on social media, and the public becomes divided.

In general, regardless of the reason for raising the issue of women's rights, there are many people who do not like these discussions and try to convince them that women are the cause of conflicts.

Timely identification of women in difficult situations in the field, including women with disabilities, individual and targeted work with them, targeted support;

Ensuring the employment of women, implementing practical measures to develop family and private entrepreneurship and crafts among them;

Together with law enforcement agencies, citizens' self-government bodies and other organizations, is personally responsible for the effective organization of crime and crime prevention among women, including the improvement of their legal culture and the strengthening of moral and ethical values .
